This release of claims and liability also extends to and includes all harm and injuries, including bodily injuries, I may suffer which are caused by or arise from any defect, breakage, or malfunction in Soccer Planet's facility, fixtures, or equipment.

I understand and acknowledge that sporting activities in which I may engage while in or using Soccer Planet's facility have inherent dangers and risk of injury, including bodily injury, permanent injury, or even death.
